

Minutes of the Full Council meeting held on Monday 13th November 2017 at 7.30pm in the Parish Office, Great Linford House, 1 St Leger Court, MK14 5HA.

Chair - all agreed that Cllr Widdowson would Chair this meeting in the absence of Cllr Panes.

1. **Apologies** were received and accepted from Cllr Panes (holiday), Crooks (other meeting) and Macaulay (personal).
2. **Declaration of members' interests** – none.
3. **Minutes of the previous meeting** held on 25th October 2017 were proposed as a true record by Cllr Foskett, seconded by Cllr Burgess and voted as 11 for, 0 against and 3 abstentions.

Confidential minutes relating to staffing discussed on 25th October 2017 were proposed as a true record by Cllr Foskett, seconded by Cllr Heale and voted as 11 for, 0 against and 3 abstentions.

Cllr Maclean arrived at 19:34

4. **Matters arising** – Cllr Stabler provided a verbal update on the MKALC AGM.
5. **Public Question time** the meeting was closed at 19:36 to allow the public to raise questions and make comments on 10 item 7.2.2 and 6.1.

Comments were made from the applicant at 4 Thorneycroft Lane about their planning application.

Cllr Maclean declared a personal interest as she knew the residents.

Daniel Chehade provided an explanation of the art works he is working on and which formed the basis of the grant applications.

The meeting was re-opened at 20:01.

6. Grant Application S137

- 6.1. Cllr Stabler proposed that a grant for £400 should be awarded to Studio Chehade towards the art project, provided that the other grants applied for are also successful. This was seconded by Cllr Heale and voted as 11 for, 4 against and 0 abstentions.

7. Planning

7.1. Report on Planning progress was provided by Cllr Stabler.

- 7.1.1. Cllr Stabler proposed that the Parish Manager, Lead Cllr Planning and the Planning Working Party should be authorised to consider and make representation to the inquiry as necessary to support the objections previously made by GLPC to Templeview Developments on Linford Lakes. This was voted as 13 for, 0 against and 2 abstentions.

7.2. Memorandum on all applications

- 7.2.1. 17/02765/ADV and 17.02767/LBC Nags Head No comment was proposed by Cllr Stabler, seconded by Cllr Burgess and voted as 14 for, 0 against and 1 abstention.

- 7.2.2. 17/02795/FUL - 4 Thorneycroft Lane Downhead Park No comment was proposed by Cllr Stabler seconded by Cllr Burgess and voted as 14 for, 0 against and 1 abstention.

Cllr Maclean did not vote and was not involved in the discussion

- 7.2.3. 17/02748/FULR3 - Land to the North of 2 Coltsfoot Place Refusal was proposed by Cllr Stabler and seconded by Cllr Burgess and voted as 12 for, 1 against and 2 abstentions. It was agreed that refusal should be sought as it is contrary to:

- GLPC Neighbourhood Plan policies S2A e, f and g. S2C S4S7S8S9S11 f and S14B
- Policies in the MK Local Plan 2001 to 2011 policy L2 and appendix, Policy H8 Policy D1 I and vi. Policy D2A I and ii. Policy D2 I ii iii and iv. T2 ii T3 iv and T10 ii
- New residential design guide SPD Section 4 detailing the place 4.13.5 4.13.10 and 4.11.39

- 7.2.4. 16/03085/FULR3 - Land to the South of 33 Germander Place No Comment. This was proposed by Cllr Stabler and seconded by Cllr Burgess. It was voted on as 14 for, 0 against and 1 abstention.

8. Correspondence and Parish Managers report

- 8.1. Speed Awareness – the action plan has been updated and circulated to all. A week of road safety is to be run 20th November and an article has been included in the current North By NorthEast. Other activities and data collecting will continue. MKC Cabinet have been made aware of the concerns raised and have agreed to review the location and data provided.
