6.2.1. 18/01291/FUL Land to rear of 222 Wolverton Road, Blakelands **Objection**

1. Car park provision is inadequate (Parking Standards 2016).
2. Rear garden provision is contrary to New Residential Design Guide (2012).
3. Front to flank distance is below 13.7 metres, as required by New Residential Design Guide (2012).

6.2.2. 18/01334/FUL 26 Smeaton Close, Blakelands **No objection**
was proposed by Cllr Calverley, seconded by Cllr Stabler and agreed by all.
